Basic Safety | Company File

- Update MCS 150
- Check MCS 90
- UCR (once a year)
- Contracts (DQ file-unit file)
- Passenger Authorization
- Set up all necessary accounts for safety purposes (MVR, CHL, consortium, SAFER portal, others)
- Prepare company package

Basic Safety | Driver File

- Order MVR & PSP
 - Make appointment for drug test through Med-Stop or other clinic
- Create request for driver in CHL portal and check if the driver is not prohibited (if a driver is prohibited, the safety manager is obligated to provide all support to the driver and to return to duty this driver)
- Create HOS profile for the driver
 - Check drug test results, and only after this, share the logbook credentials with the driver
 - Prepare a driver profile that contains the following documents
- Active Drivers

CDL, Med Card, Check of med exam, MVR, PDAT, DQ file with all forms and contract
- Terminated Drivers

+ Form of termination
- Prepare company package

Basic Safety | Unit File

- **Truck file** | Truck registration, truck annual inspection report, lease agreement
- **Trailer file** | Trailer registration, trailer annual inspection report, lease agreement
- **Unit file** | Unit List, Lease/Owned, annual inspection issue, registration, lease agreement, VIN number, license plate, make, state, year, NY decals, NM decals, OR decals, CT permit

Basic Safety | Updates

- Update MCS 150 (biennial update)
- Update MCS 90 (on insurance renewal)
- Update UCR (every year)
- Drug and Alcohol Testing Records
- Upload proof of a random testing program and a list of drivers
- Annual MVR and check of violations
- Truck registration and inspection
- **Monthly check and update of** | CDL and Med Card

Applicable Regulation: 49 CFR 382

Basic Safety | IFTA

- Load and fuel report
- Monthly mileage report
- Quarterly IFTA payments report
- Drug and Alcohol Testing Records
- Upload proof of a random testing program and a list of drivers
- Annual MVR and check of violations
- Truck registration and inspection
- **Report for each unit should contain** | Total mileages for the quarter, total fuel gallons for the quarter, average for the quarter, detailed information for payment in NY, NM, KY, OR, CT, IL

The registration and setting up of additional accounts related to IFTA are charged according to additional fees.

Basic Safety | Permits

- Add the permits to Google Drive and/or other safety-related software
- Send the needed permit to the driver
- Check temporary permits and renew them after a permanent license plate is issued
- Prepare permits for new trucks for states where required (NY, NM, OR, KY, CT)
